Dear Parents/Guardians

Thank you for supporting this year's Tattenhall Art residential taking place from Friday 16th February to Sunday 18th February 2018.

The workshops always prove to be an invaluable experience for all students involved and the intention is to complete some large scale pieces. Although students will not be in school I must stress the importance of high standards of conduct and application. This is a working visit!

The centre is located within a small village and students are asked to respect the property and privacy of local residents. There is a small shop where students will be able to buy confectionery and soft drinks but they must be accompanied by a member of staff if going off site. Students must be prompt when asked to attend meetings or a practical demonstration. Music players and mobile phones may be brought but they are not to be used during work time and the school does not accept responsibility for the loss or damage of such items. Drinking alcohol and smoking will not be permitted and any student caught breaking this rule will be sent home and their Head of House will be informed upon our return.

Usual necessities apply and students are asked to bring their toiletries, towels etc. This will be a messy three days and clothing is likely to get dirty. Students should therefore make sure they have some old jeans and shirts. We look forward to a productive and enjoyable visit and hope that your child will benefit greatly from the experience.

We will be leaving school at approximately 12:30pm on Friday 16th February 2018 and will return to school at approximately 4:00pm on Sunday 18th February 2018. We ask that parents collect students outside the Main Entrance please.

Payment can now be made and the total cost for the visit is £96. If you would like your child to attend, please complete the permission slip attached and return it in an envelope with your payment by Friday 12th January 2018.

Cheques should be made payable to **Brine Leas School** and returned with the permission slip in an envelope via the Drop Box which is situated at Student Reception.

Cash payments can be accepted when a cheque payment is not possible. Students must take cash payments directly to the Finance Office and it will be received in the student's planner.
